

SECTION A: APPLICATION DETAILS

A1. WHAT IS THE APPLICATION PERIOD FOR AIA FAMILY 360 CAMPAIGN?

The application period is from 13 January 2025 to 31 December 2025.

A2. WHO IS ELIGIBLE TO APPLY FOR AIA FAMILY 360 CAMPAIGN?

You are eligible if you fulfil the following conditions:

- All insured person(s) must be a Singapore Resident^ and hold a valid Birth Cert/NRIC/ FIN.
- All insured person(s) must be within the age limit of 2 weeks old to 65 years old (age last birthday).
- All insured person(s) must not be a citizen of a sanctioned country or a Prohibited Person.
- All insured person(s) must provide his/her Marketing Consent (defined in the Campaign Terms and Conditions) to AIA.

A3. WHAT IS THE ELIGIBLE AGE OF THE APPLICANT?

The applicant must be at least 18 years old (age last birthday).

If an individual below the age of 18 years old wish to apply, please apply using the family application form where the guardian/parent must apply as the applicant and provide the necessary information.

A4. CAN I APPLY FOR MY SPOUSE AND CHILDREN?

Yes, you can. You may apply by adding dependents on the application form. As the applicant, you can add your spouse between 18 and 65 years old (age last birthday) and/or child(ren) between 2 weeks old and 17 years old (age last birthday) into the same application. If your child is 18 years old (age last birthday) and above, he/she should apply as the applicant instead.

Please note that for this free AIA Family 360 Cover, a family refers to 1 applicant with a maximum of 5 dependents (1 spouse and up to 5 children if spouse is not included under the application).

A5: I AM CURRENTLY NOT AN AIA CUSTOMER. CAN I APPLY?

Yes. This offer is open to both AIA and non-AIA customers.
