

TERMS & CONDITIONS:

SECTION 1: AIA LIFE QUEST GAME 2025

- 1. The AIA LIFE QUEST GAME 2025 (the "**Game**") is organised by AIA Singapore Private Limited (UEN: 201106386R) ("**AIA**") and is open for participation from 5 August 2025 to 18 August 2025 (both dates inclusive).
- 2. By participating in the Game, you agree to and accept the following terms and conditions ("Game T&Cs") and agree to be bound by these Game T&Cs and any subsequent amendments, additions, replacements, variations and modifications. Please read these Game T&Cs carefully.
- 3. The Game is open to customers of AIA who access the Game via the AIA+ mobile application with an AIA+ account.
- 4. The participant may only play the Game once. The Game may be completed by clicking on the Game's banner on AIA+, finishing all stages of the Game and reaching the end-screen of the Game.
- 5. All participants who complete the Game will be shown a final end-game rewards screen, displaying the AIA Delight Points and digital vouchers that they have received and a claimable Premium Discount Voucher. The participant can access the prize from his/her AIA Delights ewallet within the AIA+ app or on the AIA+ website. SECTION 2: AIA LIFE QUEST GAME PREMIUM DISCOUNT VOUCHER TERMS OF USE

- 1. The AIA Life Quest Game Premium Discount Voucher ("**Promotion**") from AIA Singapore Private Limited (UEN: 201106386R) ("**AIA**") is only valid for the period of 5 August 2025 to 30 September 2025 (both dates inclusive) ("**Promotion Period**") and may only be used by existing customers of AIA who have played the AIA Life Quest Game and who have redeemed the Premium Discount Voucher ("**Eligible Customers**").
- 2. The Promotion shall be governed by the terms and conditions set out herein ("**Voucher T&Cs**") and by such terms as AIA may impose from time to time. Understanding these terms and conditions are important because, by participating in this Promotion, you are agreeing to be bound by the Voucher T&Cs in their entirety.
- 3. - *Single Premium/First Year's Premium means the total amount of gross premium payment due and payable on an Eligible Plan in the first policy year of an Eligible Plan. Where applicable, the calculation of gross premium shall include the amount(s) paid for additional coverage as set out in the supplementary agreement(s) that is attached to the basic policy and which bears the same policy number. It includes the goods and services tax paid for such policy and the extra premiums payable because of substandard loadings where applicable. No aggregation of premiums among two or more policies will be allowed.
- 4. Eligible Plans with premium terms of less than 10 years are **not** eligible for this Promotion.
- 5. Notwithstanding Clause 4 of the Voucher T&Cs above, all single premium plans and regular premium pay-to-age Eligible Plans (including pay-to-age plans with premium terms of less than 10 years) are eligible for this Promotion.

- a) the Eligible Customer's application to purchase an Eligible Plan ("**Application**") is accepted by AIA;
- b) the Application is dated, signed and submitted to AIA within the Promotion Period;
- c) the Application must not be in relation to any of the Eligible Customer's existing plan(s) (such as, but not limited to, a top-up, a variation of coverage; an addition of rider or endorsement; or a change of plan);
- d) the Application is not a re-submission of a previously withdrawn application;
- e) the Eligible Plan is incepted and the first premium is fully paid by 31 October 2025;
- f) there is no cancellation of the Eligible Plan within the free-look period;
- g) the Eligible Plan must remain in force for at least 12 months from its inception date; and
- h) there is no alteration to the Eligible Plan (such as a change in insured amount) within 12 months from its inception date.
- 7. An Eligible Customer may purchase and apply the Promo Code to more than 1 Eligible Plan under this Promotion.
- 8. The Discount in this Promotion are applied on a "per policy" basis.
- 9. The Promo Codes are not transferable and are also not redeemable for cash or credit.
- 10. By participating in this Promotion, the Eligible Customer hereby undertakes to immediately upon AIA's request pay AIA the full amount of any item(s) and Discount(s) given to the Eligible Customer under this Promotion, if he/she may no longer be eligible to receive or retain the item(s) and Discount(s). The Eligible Customer further consents and authorises AIA to recover/claw back such amount of item(s) and Discount(s) and set off/deduct such amount against any sums that may be due and payable by AIA under the relevant Eligible Plan, at AIA's discretion.
- 11. If the Eligible Customer cancels an Eligible Plan within the free-look period, he/she will be refunded the premium amount he/she had paid (taking into account the applicable Discount(s) applied) without interest, less all medical expenses incurred in considering the Application, and provided that no claim has been made and no deductions/set offs are applicable.
- 12. AIA reserves the right in its sole and absolute discretion to replace the Discount(s) or item(s) given under this Promotion with an item of similar value, without having to give any person any notice or reason.
- 13. This Promotion cannot be used in conjunction with any other promotions carried out by AIA unless otherwise permitted by AIA in its sole and absolute discretion. If any provision of these Voucher T&Cs is held to be invalid or unenforceable, then such provision shall (so far as it is invalid or unenforceable) be given no effect and shall be deemed not to be included in these Voucher T&Cs without invalidating any of the remaining provisions of these Voucher T&Cs.
- 14. AIA reserves the right in its sole and absolute discretion to withdraw or terminate this Promotion at any time without having to give any person any notice or reason.
